

TERMS OF USE

Donegani 2, 20121 Milan (MI), VAT number IT12609300152, (jointly, "**Partners**"), each visitor ("**User**") is invited to carefully read these terms of use ("**Terms of Use**") and the Privacy Policy. Browsing the Website implies full acceptance of these Terms of Use.

The Partners reserve the right to update and / or modify these Terms of Use at any time, without prior notice, by publishing the updated version on the Website. Therefore, before any access or use of the Website, the User is required to read and acknowledge the Terms of Use in the updated version in force on the date of access to the Website.

1. SCOPE
